**RESOLUTION REGARDING  
FIRE PROTECTION COST ESTIMATES  
AND SPECIAL ASSESSMENT DISTRICT**

WHEREAS, the Township Board (the "Board") of the Township of Homer, Midland County, Michigan (the "Township"), has the authority to provide for fire protection, including vehicles, equipment, housing and operations, and to create special assessment districts encompassing all the land and premises in the Township benefitted and to levy and collect special assessments to provide for same under the authority of Michigan Public Act 33 of 1951, as amended, MCL 41.801, et seq., (the "Act"), and

WHEREAS, pursuant to the Act, the Board has made and has on file estimates of the cost and expenses of fire protection for the Township, and

WHEREAS, the Board has accepted estimates of costs and expenses of fire protection for the Township and tentatively declared its intent to create a special assessment district to defray the costs of same pursuant to the Act, comprised of all the land and premises in the Township.

WHEREAS, the Board had previously scheduled and conducted a Public Hearing for August 22, 2012 to hear objections that may be offered against the estimates and the creation of a special assessment district comprised of all the land and premises in the Township to defray the cost thereof.

WHEREAS, the Board has been advised by counsel to reschedule and renote that Public Hearing and to conduct same thereafter.

NOW, THEREFORE, BE IT RESOLVED as follows:

1. Pursuant to the Act, the Board shall meet at 6:30 p.m. Eastern Standard Time on 10<sup>th</sup> day, October, 2012 at the Homer Township Hall, 522 North Homer Road, Midland, Michigan and conduct a Public Hearing to hear objections that may be offered against the estimates and the creation of a special assessment district comprised of all the land and premises in the Township to defray the cost thereof.

2. The Township Clerk is herein directed to provide notice of the Public Hearing in accordance with the Act.
