While attending the Michigan Township Association's annual conference in January, I stopped at the Republic Waste booth and found out that they now offer an expanded recycling program. Planning Commission

During the year the Planning Commission met 16 times, 12 monthly meetings, 2 special meetings to continue review/revision of the zoning ordinance, and 2 public The major focus of the hearings. commission was updating the zoning ordinance which had last been done in 1996. Between 1996 and 2007 there were 12 spot amendments to the ordinance which led to some inconsistencies among areas. There were also areas that were outdated as newer trends had not been incorporated and old ones deleted. The review process is now completed, the attorney is reviewing the document, following which the Planning Commission will schedule a public hearing, hopefully sometime in April. We will put a notice of the hearing in the Midland Daily News, post it on our website, and post it at the township hall. In addition to the revised document being posted on our website, printed copies will be available at the office of the Midland County Clerk, and at the township hall once the hearing date is announced. The Planning Commission is now posting the minutes of all meetings on the Township website. Go to 'COMMISSIONS/COMMITTEES' section of the HOME page and select 'Planning Commission'.

The Township website has been totally revised and updated. New sections have been added and much new information is available. Updates are now constantly being made. Check our new 'CURRENT NEWS' section that identifies upcoming events, position openings, special meetings and more. The Parks/Recreation section has all new 2011 schedules and information. General Open Burning

Michigan air quality and solid waste regulations prohibit open burning that creates smoke or odor nuisances. You may burn trash from a family dwelling in an approved container located on your own property, as long as you do not violate any other air pollution rules (like smoke and smells). An approved container is one constructed of metal or masonry with a metal covering device with openings no larger than 3/4 inch. Forest fire prevention regulations require you to obtain a permit when the ground is not snow-covered. Burning permits do not allow burning prohibited by other regulations. permits may be obtained using the DNR webpage at www.michigan.gov/burnpermit, or by calling toll free at 866-922-2876 between 8 a.m. and 8 p.m. daily.

FREE Smoke Detectors for Low Income Families

Interested Midland County residents should contact the American Red Cross at 989-631-3262, Ext 0. Residents will be asked questions during an intake process, including annual household income. Residents may receive between 2 and 5 free smoke detectors based on home size, number of stories and number of bedrooms. The smoke detectors will either be delivered by the local fire department or can be picked up at the Red Cross Office in Midland.

Providing Emergency Information and Instructions:

That is the purpose of **1-888-TELL-MORE**. If a tornado, flood, chemical accident or some other extraordinary event occurs, emergency responders will provide information to you about the event and its potential effect on the community through this emergency information hotline. Call this number for information and instructions when you become aware of an emergency or disaster in You may also tune to Midland County. WMPX AM 1490 or WMRX FM 97.7 to receive emergency information.

NIXLE – A New Way to Reach You with Important Information

Providing information to the public during emergencies and disasters has always been an important part of emergency management. In the early stages of an event, alerts and emergency instructions are distributed as quickly as possible. As activities change from emergency response to recovery operations other messages are shared with the public about such things as shelter, damage assessment and disaster assistance. In Midland County we attempt to use as many

methods of communication as possible. Messages are distributed to television and radio stations. Regular programming on Midland Government Television (MGTV-96) is interrupted to display information. Messages are recorded on the Midland County Emergency Information Hotline 1-888-835-5667. These methods along with warning systems like outdoor warning sirens and NOAA Weather Radio alert residents of emergencies and provide information.

The most effective way of providing information is to reach citizens right where they are. For many, that means contact through a computer or mobile device via an email or text message. The capability to make contacts like these has been available but the cost of implementing the process was prohibitive. Now that has changed.

In 2009 we were introduced to an Internetbased service called Nixle. It's a service not unlike that provided by Twitter, only Nixle is for public safety not social networking. Local agencies including the Midland Police Department, Midland Fire Department, and Midland County Office of Emergency Management have registered as user agencies on Nixle, which means we can distribute text messages and email via the Nixle service to residents who have registered to receive them. Messages can range from general information to alerts with emergency instructions. In order to receive messages through Nixle you first must register on the system. Here's how:

- Go to www.nixle.com
- Click "Register Now"
- Create an account choosing a User Name and Password
- Enter the email address/cell phone number to receive messages
- Enter address or nearby intersection
- Click "Sign Me Up"

To customize your account you can click on "Locations" and then "Add New" to add addresses. For example, if you want to receive messages where you work in addition to where you live you would add the address of your workplace. By clicking on "Settings" you can receive messages from each agency and set message priorities. This is important because you must "opt-in" to receive local messages. If you need assistance in signing up you may contact Nixle at <u>support@nixle.com</u>. Please note that the standard fees charged by your provider for wireless network messaging will apply to messages received from Nixle.

Keep in mind that we will continue to use all the methods of community warning and notification that you are already familiar with. Nixle is just an addition. And at least for now Nixle messages will not be the first sent. As we get experience using Nixle and as our own capabilities change and grow the use of Nixle will likely expand. But before anything happens at all you must sign up. So please follow the instructions provided and register to receive messages through Nixle.

BUILDING CODE INFORMATION

How do I know if I need a permit? If your project is a deck or utility barn under 200 sq. ft., a building permit isn't necessary. But be sure to check on any zoning setbacks. **Everything else needs a building permit**, even if you are doing a demolition of any kind to a structure, pool, pond or lean-to. Also, if the work falls under a "No Charge" category, you still need to pursue a permit. So call me! The call is cheap compared to the double fee and a citation charge of

construction fraud filed against you for proceeding without a permit.

Worksheets, checklists and permit applications for your next project or new home can be obtained by contacting me, or by going online to the township website, then click "Documents", and print off both the application and requirements. Before completing the paperwork, please call me for any updates to the building code (always changing) or the new Energy code. Consider also any electrical, plumbing or heating questions because calling the inspector to inquire may save you a lot in the end.

<u>Chippewa Nature Center:</u> From Forest to Furnishings Woods Used in the Recent Renovation

As you enter the new Preschool and remodeled Visitor Center, you will notice the large amount of lumber that was used during the process. The majority of it was harvested from Chippewa Nature Center's (CNC) 1,200 acres. This lumber is considered a renewable resource. A total of 11 species of trees were used in the renovation including: ash, hickory, red and white oak, Norway spruce, red and white pine, sassafras, elm, walnut and butternut.

The trees used were carefully selected based on several criteria, such as invasive exotic species like Norway spruce. Eradicating these trees allowed others like white pine (a native species and Michigan's state tree) to receive more sunlight to live and grow at a faster rate. Diseased trees such as ash infected with emerald ash disease and trees dying of old age like the large oaks just east of the Wood Duck Pond were also harvested. Between harvesting the ash and oak in this area, several small oaks and a large number of hickory saplings were also given more space to grow. A fallen butternut was also a perfect candidate for renovation lumber.

CNC staff did all of the cutting for the project themselves. Trees were carefully felled to prevent damage to ones that had been flagged as important trees to keep, and in such a way that their unused tops created brush piles for wildlife cover and hosts for fungus. A portable band mill cut the logs into rough sawn lumber. Each board was then stickered – carefully piled in 3 foot widths with stakes in-between to provide adequate air flow – and left to dry for 1-2 years. Lumber to be used for boardwalks did not need to be dried as it would remain in the elements.

Lumber that was to be used in the interior parts of the building was sorted and sent to a kiln dryer, equivalent to putting the lumber in an oven for 4-6 weeks. Decreasing the moisture content helps prevent the lumber from moving/warping as much once it is assembled.

The ash used for exterior siding underwent a different drying process called thermal kiln drying. The temperature of the wood is raised rapidly using heat and steam to a level of about 291°F, and is increased steadily up to 366° F and in some cases, as high as 400° F. Steam is used to prevent the wood from cracking and burning. In the process, the cells of the wood collapse, making it harder for moisture to move into or through the wood. This helps keep the wood from shrinking and swelling, and helps preserve the wood without using chemicals. The wood smells baked and turns brown, making it look stained. After sun exposure, the color turns to grev.

Lumber used in the interiors of the buildings was sent through a table saw and a planer. Some of the lumber was molded into tongue and groove paneling and lap side siding. Both the heartwood and sapwood (inner and outer portions of the log) of the walnut trees were kept, which is why the walnut in the remodeled Visitor Center has light wood mixed in with the dark wood. Wood harvested at CNC was also used to create cabinet casing and doors and the wood counter tops.
